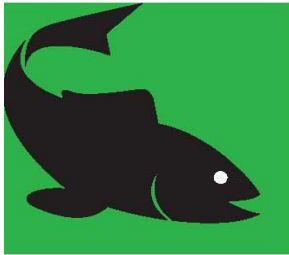

1. All MN state laws and the following tournament rules apply.
2. Fishing is: St. Croix River from Stillwater Bridge south to Prescott Bridge north.
3. Tournament Hours: 7:00 AM – 2:30 PM
4. There is a 10 fish limit of Walleye & Sauger combined per team
5. Total weight is your score
6. Walleye and Sauger must be 15"
7. All boats must be launched at **Beanies** (fee incl. with entry)
8. In order to qualify, the team must be at **Beanies** by 2:30 PM
9. Weigh-in: 2:30 at **Beanies**
10. Tournament meeting at the Beach Bar at 6:30 PM on Friday, May 19, 2017
11. One member of each team must be present at the tournament meeting
12. Failure to attend the meeting = disqualified and entry fee is forfeited
13. Lunch and soft drinks at the Beach Bar after the tournament (included with entry fee)
14. All entry fees to be paid at the Beach Bar by May 19, 2017
